President's Message

At our February membership meeting, we have two presentations planned. First, we will have a short presentation by Dominion Power on their rational for why they believe an additional power line is needed for the Northern Virginia region, and our regularly scheduled meeting on transportation.

If you recall, in November Dominion Power had originally asked to speak to the Federation; to ensure we heard from both sides, we also invited Virginia's Commitment to attend and speak on why the power line wasn't needed. For scheduling reasons Dominion Power wasn't able to attend, and we heard only from Virginia's Commitment. I've previously written about that experience, and am now looking forward to hearing the other side of the story.

With the Virginia General Assembly revamping the transportation funding they adopted last year in a mad rush to remove the abuser fees, we will hear from the most important legislative result from last year's session – the Northern Virginia Transportation Authority or NVTA. Through all the funding that was jerry-rigged for the Northern Virginia and Hampton Roads areas, the NVTA was empowered to fund transportation improvements here in Northern Virginia. There are restrictions on how the NVTA votes to approve the items they fund, including the percentage of voting parties as well as the percentage of population represented by the voters. We will hear more at our presentation with NVTA, Fairfax County Office of Transportation, and Virginia Department of Transportation representatives. Personally, I think the key factor is that, like the 800-pound gorilla in the room, if Fairfax doesn't vote for an item, it probably won't be passed.

Coming up next month is the Federation's most important event of the season, the annual Citizen of the Year banquet. This year's recipient, John Horesji, is especially worthy. John has worked tirelessly, not only here in Fairfax County, but statewide, including spending time in Richmond, dedicated to helping those most in need. For many years he has assisted within Fairfax County government, in his service on the County's Advisory Social Services Board, within church charitable activities, such as Catholic Charities, and in general advocacy, through the Fairfax Alliance for Human Services.

At the banquet, we will be treated by a well-known duo of guest speakers. You've heard them speak individually, now hear them in unison. The Honorable Thomas M. Davis III, Congressman of the 11th District of Virginia, and The Honorable Gerald E. Connolly, Chairman of the Fairfax County Board of Supervisors, will share the podium. The banquet is scheduled for Sunday, March 9, 2008 at the Tyson's Corner Crown Plaza Hotel. Additional details can be found in this *Bulletin*. Hope to see you there!

Tysons Land Use Task Force Update

The Task Force was created in 2005 to consider the impacts of Metrorail stations and create a vision of what Tysons Corner may look like in 30 years. The Task Force has held over 50 public meetings, identified areas of consensus, and followed a set of guiding principles based on public input. Volunteer Mobilization Center Regional Exercise

Next month, Volunteer Fairfax will participate in a Volunteer Mobilization Center Regional Exercise to practice managing, mobilizing and disbursing volunteers in response to support recovery efforts after "Tropical Storm Zodiac" passes through the National Capital Region.

As part of this exercise, Volunteer Fairfax will stand up its Volunteer Mobilization Center and practice processing spontaneous volunteers. During the exercise, real-life challenges will help participants focus on special scenarios that often occur during disaster situations.

As an organization that will be integrally involved in the recovery efforts after a disaster, it is important to understand the process that spontaneous volunteers would go through, and how they can be used in recovery efforts. We invite you to experience this for yourself during our exercise, which will be held:

We are asking participants to play the role of spontaneous volunteers and walk through the Volunteer Mobilization Center. Participants will then break into working groups to discuss issues pertinent to their role in the recovery process, including identification, communication, volunteer opportunities and placement. At 2:00 p.m., we are asking partner agencies to remain so that we can further clarify how Volunteer Fairfax will work with the nonprofit community in the event of an emergency, and how agencies can secure volunteer resources during times of disaster through the volunteer center.
