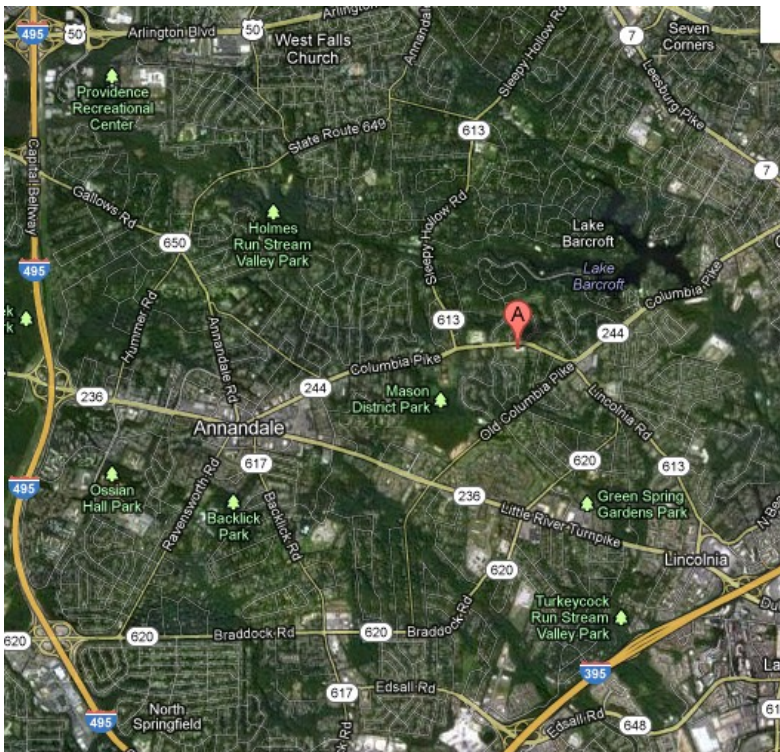

Membership Meeting Minutes

Thursday, January 17, 2013

The January meeting of the Membership of the Fairfax County Federation of Citizens Associations was called to order by 1st Vice President Rob Jackson at 7:30 p.m. at the Fairfax County Public Schools (FCPS) Administration Center in Falls Church.

Program

FCPS Proposed Budget for FY 2014—Kristen Michael, Director of Budget, FCPS—On January 10 the superintendent released the proposed budget for next year. Ms. Michael's described the "budget drivers" and proposed budget, using the official FCPS set of slides and she answered questions. Approval of Board Meeting Minutes: Ed Wyse, Recording Secretary: The membership approved the minutes of the December 2012 membership meeting.

Treasurer's Report: Scott Schlegel, Treasurer—Scott was not present but provided a written report. This report lists four fewer members than the membership chair's listing; the officers will reconcile the lists. The board voted to receive and file the report.

Board & Committee Reports

Budget Committee: Linda reported that Susan Datta, Director, Department of Management and Budget will meet with the Federation's Budget Committee co-chairs on February 27 and the County Executive Ed Long will speak at the March 21 meeting. A volunteer has agreed to lead the Federation's review of the budget for the Community Services Board. (Note: Several days after this committee report was made, the date of the March membership meeting with Mr. Long was changed to March 28.)

Citizens Association Services: Don Hinman—no report

Education: Leonard Bumbaca, Ed Saperstein, & Tim Thompson—Tim reported the committee is preparing its budget input and will present its proposed position to the Federation board on January 24.

Environment: Flint Webb—Flint submitted this report via e-mail for inclusion in the minutes.

Sierra Club/Great Falls Group – January 15

The Great Falls Group held a meeting to discuss hydro-fracturing (fracking). Jeff Brown from Pangea-Global, a fracking advocacy group, presented a good summary of how fracking is done and some of the environmental concerns. Jeff made a point that the industry recognizes the need for regulation but feels that when done responsibly it does not need to be an environmental concern. I made the point that regulations are only good if there are regulators to ensure that they get followed and that the recent crop of Republican nominees were all for abolishing the EPA. Jeff said that mostly States are in charge of overseeing the industry. I pointed out that States are cutting back on their environmental budgets as well. A member in the audience who does superfund remediation stated that PA regulators are discouraged from regulating the oil and gas industry because the Governor says that they need the jobs that fracking brings to the State. Jeff was courageous to make a presentation to the Sierra Club and the discussion was frank and polite and could form the foundation of a fruitful exchange between the industry and environmental groups.

Green Breakfast and Visit to Huntley Meadows Park – January 12

Kevin Munroe, the Manager of Huntley Meadows Park, spoke about their wetlands restoration project. The project will begin this spring with staging of equipment but will not start in earnest until after the spring nesting season. The plan is to put in a flow management device that will allow the Park to actively manage the water level so there will be roughly an even split between open water and marsh area. That will provide the maximum biodiversity of the park.

The discussion prompted me to go visit Huntley Meadows Park the next day and I saw a muskrat, a beaver, and many varieties of ducks and birds. I was amazed that there was an active beaver lodge right under the boardwalk even encompassing the bench on the boardwalk. I very much recommend a visit!

Metropolitan Washington Air Quality Committee, Technical Advisory Committee – January 15

Ana was out of town so I filled in by attending the January MWAQC TAC conference call.

The Washington Metropolitan Area is seeking re-designation attainment of the 1997 fine particulate matter National Ambient Air Quality Standard (PM2.5 NAAQS). There will be a public hearing on February 25th. For more information about the re-designation request see <http://www.mwcog.org/environment/air/sip/default.asp>.

There was also a discussion about a recent ruling by the DC Circuit Court Remanding the PM2.5 NAAQS Implementation rule which will mean that EPA will not be able to act on approving the re-designation request until the legal issues are resolved, but they will probably have to be resolved before the Washington Metro Area will submit the re-designation request in March.

The other significant news is that the Potomac River power plant emissions permits have been revoked. The plant is now permanently closed with no prospects of re-opening!

Braddock District Council: Art Wells—(Charlie Dane reported) —The January 9 meeting featured presentations and discussion with leaders of four other district councils (Lee, Springfield, Mason, and Providence) to share information about each council, common problems, and best practices. The Aging in Place committee is quite active.

Lee District Council of Civic Organizations: Chris Soule—No report.

Mason District Council: Roger Hoskin—Roger provided this report to the board via e-mail.

The Mason District Council (MDC) had their "town meeting" Tuesday, January 15th, at the Annandale United Methodist Church. We counted about 190 "sign-ins" but realistically, I think attendance was over 200. We had a moderated panel which consisted of Supervisor Gross, Mason District School Board Representative, Sandy Evans, commander of the Mason District Police District Captain Gun Lee, and Susan Epstein, representing the Fairfax County Department of Code Compliance. The meeting lasted over two hours and could have gone on longer.

The council had conducted a survey to identify major issues of concern to the community. Over 600 people responded. High on the issue list was property maintenance and the high number of code violations. Crime, overall, was down but burglaries were up. Citizens were also concerned about speeding on several major roads including Little River Turnpike and Sleepy Hollow Road. The major school issue was overcrowding and the location of a proposed new elementary school in Mason District. Yes, even Glasgow, our new middle school which was thought to have more than enough capacity to meet foreseeable needs when it was built, is now bursting at the seams.

MDC signed up 4 new associations at the meeting and with follow up could add several more. MDC's next meeting will be in February.

Fairfax County Transportation Funding

Cathy Hudgins, Hunter Mill Supervisor, recently responded to our inquiry concerning transportation funding for Fairfax County:

Thank you for contacting our office regarding transportation funding for Fairfax County. Transportation funding information was compiled for the Countywide Dialogue on Transportation (CDOT) series earlier this year. The presentation developed by Department of Transportation staff lays out the 10-year, eight billion dollar capital improvement program. An Op-Ed Article on Transportation Funding

The following is an op-ed article, written by Rob Jackson, First Vice-President of the Federation, that appeared in the Fairfax Times on January 11, 2013.

Fairfax County legislators should not be "protecting" the General Fund

It's that time of year again. The General Assembly has just reconvened in Richmond. The capable delegation representing Fairfax County is working for our best interests — or is it?

Recently, I've heard a number of them promise to protect the Commonwealth's General Fund from being used to pay for transportation projects. The General Fund (almost \$17.18 billion dollars for FY 2013) pays for many things, the largest of which are: education, health and human resources and public safety. Non-General Fund revenues (\$24.52 billion dollars for FY 2013) also pay for many things, the largest of which are: education, health and human resources and transportation. For the current fiscal year (2013), only \$45 million of General Fund revenue was spent on transportation. Should more General Fund money be used for transportation?

From a Fairfax County resident's perspective, I think the clear answer is "yes." Using some General Fund money for transportation would help balance the unfair financial relationship Fairfax County has with the Commonwealth.

Fairfax County residents heavily contribute tax dollars to Richmond, but, in many areas, don't get much back. For example, in FY 2011 (the latest available year), Fairfax County residents paid a whopping 23.4 percent of the entire Virginia Individual Income Tax. Yet we received a paltry 9.25 percent of the Standards of Quality (SOQ) state aid to K-12 education for the same time period. It's clear Fairfax County income tax dollars help keep real estate taxes lower in much of the rest of the state, as we help pay for much of their public school expenses, and then we pay high real estate taxes to operate our public schools.

Sure, we get some benefits from other expenditures from the General Fund — Public Safety, Higher Education, Health Care (Medicaid). Also, as a wealthier locality, we cannot expect to break even. But does anyone think we get an overall fair deal from Richmond?

We are never going to be near to receiving a fair share of the tax dollars we send south, especially not for public schools. Therefore, shouldn't our senators and delegates try to get some more of this revenue for transportation? Shouldn't they be working to reduce the huge gap between what Fairfax County residents pay in state taxes and what we receive? Instead of complaining about the unfairness, our elected representatives should be trying to get transportation money from the General Fund. Senators and Delegates, please represent our interests, not those of the rest of the state.

Schedule Change for March Federation Meetings

As shown on the Calendar (Page 3), the Federation's Board meeting will be on March 21 and the membership meeting, on March 28. These are changes from the previously published schedules. The locations for those dates are unchanged; therefore, the membership meeting will be held at Braddock Hall.

Transportation Plans for the Capital Region

The latest National Capital Region Transportation Planning Board analysis estimates that by 2040 there will be more than 900,000 new daily commuting trips -

- 452,000 - More solo commute drivers.
- 241,000 - More car pool passengers.
- 55,000 - More bus riders.
- 160,000 - More train, pedestrian, bicycle trips.

In other words 8 in 10 of all *new* commuter trips will use and depend upon the regional highway and bridge network, which is projected to grow by only 7%. The last slide is entitled "Addressing the Challenges Highlighted by the 2012 CLRP (Constrained Long Range Plan)".

Virginia Gov. Bob McDonnell on Tuesday released the names of 16 road and transit projects, including four in Northern Virginia, that would benefit from some \$3.1 billion generated by his transportation funding plan. Here is the full list of projects:

- Dulles Metrorail Extension Project
- Extension of passenger rail to Roanoke
- Increased train service to and from Norfolk
- I-66/Route 28 interchange in Fairfax County
- I-95 interchange relocation in Stafford County
- I-95/I-64 overlap improvements in Richmond
- I-64 capacity improvements between Newport News and Williamsburg
- Route 606, Dulles Loop in Loudoun County
- Route 29/666 Interchange in Culpeper County
- Route 340 bridge replacement in Warren County
- I-81 bridge replacement over the New River in Montgomery County
- I-81/I-77 overlap capacity improvements
- Numerous bridge replacements statewide
- Major interstate reconstructive paving projects statewide
- Track improvements Newport News to Richmond and Richmond to D.C.
- Unpaved road projects, statewide.
