

Letter to the School Board re: Strategic Plan

January 26, 2015

Members of the School Board and Dr. Garza:

As you continue to engage in discussions to refine the Fairfax County Public Schools (FCPS) Long-Range Strategic Plan, the Board of the Fairfax County Federation of Citizens Associations (FCFCA) would like to contribute our thoughts to your efforts. We are pleased that FCPS is engaging in this type of analysis, as the Strategic Plan will help crystallize FCPS' thoughts about its biggest challenges as well as its largest ambitions. With that in mind, we suggest a focus on the schools' most important/ pressing needs that includes the following priorities:

- Adjust the FCPS curriculum toward meeting the goals embodied in the Portrait of a Graduate, piloting innovative programs where appropriate. We hope the Strategic Plan will provide guidance and be adjusted accordingly regarding this project for years to come.
- Correspondingly, adjust professional development toward achieving the different methodologies needed to achieve this goal.
- Develop a strategy to procure alternative sources of funding, including an increased focus on business partnerships. Our schools engage in annual battles with both Richmond and the Fairfax County Board of Supervisors to increase funding for our schools. We believe the strategic plan must provide guidance on how to help ameliorate this problem.
- Improve access to high-quality early childhood education, and ensure Kindergarten readiness. Excellent public preschools may attract paying families as well as serve our low-income population. We know that addressing our children's needs as early as possible helps reduce remediation costs, may help reduce the achievement gap, improves graduation rates, and prepares our children for success.
- Attract, develop, and retain a superior workforce. This large idea requires many smaller projects in order to be realized, as strategic thinking often does. The Federation hopes FCPS will continue to place central emphasis on this issue.
- Emphasize a creative approach to solving infrastructure problems. Our capital needs have long outstripped the available funds, we hope the strategic plan will help guide us toward new solutions, such as the recent project to repurpose an existing office building for use as Bailey's Upper Elementary School.
- Accentuate our commitment to integrating cutting-edge technology into the classroom and throughout FCPS. To implement the ideas embodied in the Portrait of a Graduate will require investments in technology to customize learning experiences, extend learning outside of "traditional" school parameters, improve communication among all stakeholders within FCPS, and provide technological access for all students.

We appreciate the opportunity to share our priorities with you, and look forward to working with you as you embark upon this important project.

Testimony at School Budget Hearing

At the January 29, 2015, School Budget Hearing, Ed Saperstein the Co-Chair with Nancy Trainer of the Education Committee, spoke on behalf of the Education Committee of the Fairfax County Federation of Citizens Associations. After he introduced himself, he said:

First, we'd like to commend Superintendent Garza for making tough decisions and coming up with a cooperative budget number.

We agree with focusing on increasing compensation for FCPS employees as compensation is crucial in trying to attract and retain a superior workforce. In continuing to develop your thoughts on salary, we recommend considering flexible compensation packages as younger employees could have different needs than employees close to retirement.

We understand that minimum and maximum class sizes are being reconsidered. We recommend flexibility to allow for exploring ways to reduce class size in the most needed courses. In this spirit we recommend trying the following pilot program in some high schools which may require a waiver or discussion with state authorities. We suggested this idea last year as well, but reiterate our support for creative approaches to dealing with high class sizes.

The pilot program is to ask some high school principals to choose one or two courses to have much larger class sizes than normal, and use the related cost savings to have reduced class sizes in some other courses. The larger classes could be taught similar to college lecture classes and, if feasible, periodically broken down into smaller groups. Teachers teaching the larger classes could get a bonus or reduced number of teaching periods, but this should be done in a way to lower the overall cost of that larger class.

Further on class size, the proposed budget has 40 extra teacher positions to help alleviate large elementary school class sizes. For transparency, we recommend that later this year FCPS states the impact of these extra positions.

FCPS is seeking to increase revenue by recruiting business partnerships. We encourage this effort and also to explore other ways to broaden the revenue base. One idea you may wish to consider, as mentioned in the Federation's 2015 Legislative package, is for the education and medical communities to partner to increase the Virginia tobacco tax and allocate the increased revenue to health care and education. The current Virginia tobacco tax per pack is much lower than the national average, and even substantially lower than our neighboring major tobacco growing states.

There appears to be better cooperation between the School Board and Board of Supervisors. We appreciate this and encourage continuing to improve cooperation as we believe this helps in providing quality education in a cost-effective manner.


School Budget FY2016


A new posting at the Federation website compares the FY2016 County school budget to school budgets for previous years, back to FY2000. The Excel workbook is:

Two graphs that might be of particular interest are the FCPS demographics and the cost per student:





The large increase in the ESOL membership was due in part to an influx of students from Prince William County when that county tightened its rules on illegal immigrants. Notice that the cost per student (total operating budget divided by total enrollment) has decreased from its peak at the end of the housing bubble. It is higher than in FY2000 but not much higher per equivalent student. The number of "equivalent members" uses the teacher assignment ratio. An ESOL student is counted as 1.4 students. A student receiving free/reduced-price meals is counted as 1.5 students.

Code Compliance

Upon receiving a complaint, the Division of Code Compliance (DCC) will conduct inspections. Many code violations, especially parking violations (e.g., commercial vehicles in residential neighborhoods), occur between 6 pm and 6 am — hours that the DCC does not normally work. Citizens in the Mason District have been complaining about this dilemma for months, with no resolution.

Reston Redevelopment—Phase 2

On January 29, more than 90 people attended the Reston community meeting to discuss the second draft of the Phase 2 (suburban areas) of the Reston Master Plan. Phase 2 deals with the land at and around the Village Centers. (Shopping centers in Reston are called Village Centers because the people of Reston, especially founder Robert E. Simon, wants these areas to be gathering places for the neighbors.)

At the meeting, several people expressed concern about language in the latest draft that does not constrain redevelopment of Reston's Village Centers. Terry Maynard, speaking for the Reston Community Association, read <u>a prepared Reston 2020</u> <u>statement</u> concerning the issue, noting that no limits on density are defined nor are Village Center boundaries prevented from expanding. Given the history of adverse consequences from imprecise planning and zoning language, Reston 2020 proposed that the plan include no language on redevelopment unless it had specific constraints.

A Redevelopment Issue at Seven Corners

The County is struggling with a decision concerning redevelopment at Seven Corners. The decision pertains to the use of the former Willston school site. The school system wants it for a school. Supervisor Gross wants it for a new government building to provide health, mental health, alcohol and drug referral services, and community services — at a cost of over \$120M. Asbestos contamination and ADA noncompliance make the existing building unusable. The Federation gets involved in zoning and redevelopment discussions only when there is a countywide issue. In this case there are three issues of countywide significance:

- There appears to be no cost/benefit analyses of the alternatives. Such decisions should be based on facts concerning costs and benefits.
- 2. The \$120M or so would be raised by an Economic Development Agency bond. Such bonds were instituted so the county could give low-interest loans to private enterprises. This EDA bond would be redeemed by revenue received not by a private enterprise but by taxpayer dollars. Using an EDA bond circumvents the bond-referendum process that is required for General Obligation bonds. At present 27% of the County's debt is funded by EDA bonds, which were never authorized by the taxpayers.
- The decision process is unclear and should be more transparent.

On another issue, a resident task force has been and will be meeting to decide the revitalization plan for the Sears site (Section C of the Seven Corners plan) during the month of February. The Planning Commission will hear the staff report for the final Seven Corners Revitalization Comprehensive Plan Amendment on February 26.

2016 County Budget: A 7% Tax Increase?

The Federation will be considering the County and school budgets in February and March of 2015.

According to its website, Fairfax County is facing budget shortfalls due to the tepid recovery in the residential and commercial real estate markets and increasing spending requirements. In addition, the ripple effects of federal and state budget issues continue to impact county revenue, including sales tax receipts, the Business, Professional and Occupational License (BPOL) tax and hotel taxes.

Fairfax County Executive Edward L. Long is scheduled to present his multi-year FY 2016-2017 budget plan at the Feb. 17, 2015, Board of Supervisors meeting. Fairfax County Public Schools (FCPS) Superintendent Karen K. Garza released her proposed FY 2016 budget plan on Jan. 8, 2015.

Slides from the November 25, 2014, joint meeting between the Board of Supervisors and the School Board show that an increase in county expenditures of 4.93% is planned. (Inflation is expected to increase less than 2% and population, less than 0.7%.) The largest increase in expenditures will be for employee compensation, which will increase more than 4%. Despite a projected 3% increase in residential real-estate values, the county budget shortfall is expected to be approximately \$100M, or \$250 per household. When combined with the increase in real-estate values, this shortfall will require that residential taxes increase more than 7% — approximately the same as the residential tax increase in FY2015.



Cigarette Tax

Virginia's cigarette tax rate is currently six times lower than the average rate of other East Coast states . Out of the USA's 50 states and DC, Virginia is ranked 50th of 51. If Virginia raised its cigarette tax to \$2.00 per pack-the East Coast average-we could raise up to \$500 million dollars in revenue for Virginia Pre-K – 12 education. (http://fundvaschoolsnow.com/)

If distributed in proportion to the number of students, Fairfax County would receive 14%, or \$70 million.

Chairman Bulova had indicated in a statement that, in response to a resolution of the Federation, she was asking for an audit of the System Gift Funds and the Friends of the Library groups. Ed Wyse reported that he made clear to the Chairman and the Auditor that the Federation had called for a comprehensive audit of the Library Administration and not of the Library Foundation or the Friends of the Library groups. Chairman Bulova acknowledged that the misinterpretation of the Federation's position occurred within Chairman Bulova's office. Subsequently, the Auditor to the Board of Supervisors has sent out a form to each of the Friends groups requesting information, and the Friends groups are upset about the form.

Federation Appointments: Tim Thompson

<u>Chairman of Resolutions Committee</u>. Due to the recent passing of Bill Hanks, we are in the process of looking for a new Chairman of the Resolutions Committee and a new Federation representative to AHOME.

Library - Kathy Kaplan: The Auditor of the Board sent out a letter and a questionnaire to the 21 Friends of the Library groups on January 13, 2015.

On January 14, 2015, the Library Board met and from written notes sent me by a branch manager who attended, it appears the audit has generated a great deal of ill will and mistrust of the County among the Friends' groups. The various Friends' groups are individual, independent nonprofit organizations, 501 (c) 3. Two of the library trustees are on Friends' boards, Liz Clements for George Mason Regional Friends and Don Heinrichs for Sherwood Regional Friends. They both expressed frustration at the audit. There apparently is no way to intelligently complete it. Liz Clements demanded that the county has to provide more information as to why they are asking for this audit.

Some of the Friends have sought legal advice as to how to fill out the document which one Friends' president described as "incomprehensible and weird." It is clear from the document that the Auditor of the Board hasn't the foggiest idea how Friends conduct their operations.

At the meeting with Sharon Bulova it was stated that a new MOU, memorandum of understanding, will be given to the Library Board by the BOS at their joint meeting, Tuesday, January 20 at 10 am, Government Center, Room 9/10. Since the MOU is currently between each Friends' group and the Library Board, one assumes the Library Board will have to vote to approve any changes to the MOU.

Report from Mount Vernon District Council

Katherine Ward submitted the following report from the Mount Vernon Council of Citizens' Associations, citing the areas of current interest:

<u>Daycare Centers</u>: The influx of permits to build daycare centers in or on the edge of residential neighborhoods. The primary issues are related to traffic congestion on neighborhood streets.

<u>Conservation Easement Changes and Water Quality Issues</u>: The owners of the Collingwood Library and Museum of Americanism, a non-profit located on 8 acres along the Potomac River, are seeking to amend their existing Special Exception Amendment (SEA) in order to subdivide the property. The changes to the SEA, if approved, would reduce the size of conservation easement that was established in perpetuity in 2000 and the use of a water quality credits in order to accommodate the subdivision of the 8 acres, permitting new residential construction on the property. A resolution opposing this amendment to the SEA went before the MVCCA General Council at the Jan meeting.

Report from the Library Committee

Board of Supervisors (BOS) Chairman Sharon Bulova told the Federation's Tim Thompson, Bill Barfield, and Ed Wyse she would send a "clarification" letter to the BOS and others that the Federation never requested an audit of the Friends of the Library. There is no evidence that she sent the clarification letter. She also said that she herself was ordering her Board Auditor to do the audit. The Auditor stated at that meeting he would send Control Self-Assessment (CSA) forms for the Friends to fill out. At a later meeting with the Fairfax Library Advocates (FLA), Jim Shelton, the Board Auditor, said he would write the Friends that filling out the CSA forms was voluntary. The Friends have not received such a letter. The FLA's Dennis Hays reminded Mr. Shelton, who wrote back that writing the letter was beyond his "purview". He told Dennis to consult with other county officials. The deadline for them to return the CSA forms is mid February. Dennis will write a second letter to Jim Shelton asking him again to make public his statement that filling out the CSA audit forms is voluntary.

Dennis has also asked to have the County fulfill the request of the Federation for an audit of the library and the System Gift Fund (the discretionary money that comes from sale of ongoing books). Chairman Bulova refused the Federation's request for a comprehensive library-collection inventory.

The Library Board has appointed a three member committee to work on a new Memo of Understanding between the Library and the Friends of the Library.

Dennis and Kathy Kaplan went to Richmond to get the library bill, HB2066 (making libraries an essential part of the Commonwealth's provision for public education), passed by the subcommittee. We succeeded, with Delegate Mark Keam's help.
