New Business -

- 1. PFAS in Drinking Water Membership meeting: PFAS (per- and polyfluoroalkyl substances) have been found in Fairfax County drinking water at concentrations in excess of Environmental Working Group (EWG) guidelines levels (5.5 ppb). Our May 27th Membership meeting will be dealing with this issue. Fairfax Water has requested that they go first and then they would leave and let EWG to take the floor. The plan is to give Fairfax Water 20 minutes to make their presentation and then 10 minutes for Q&A followed by the EWG for with a 20-minute presentation and 10 minutes for Q&A. We will also be holding elections of officers for next year so there is a hard stop after 1 hour. For additional information about this issue see:

- 2. Resilient Fairfax: Climate Adaptation and Resiliency Plan (CARP): Fairfax County is starting the process of developing the CARP. The first meeting was held on May 5th. The recording for the May 5th meeting is at https://www.ebmcdn.net/fairfax/fairfax-cable-viewer-cc-r-embed.php?viewnode=Resilient Ffx CommAdvisory Group CAG Kickoff. They are

re-branding the program to "Resilient Fairfax" but the initial step is to develop the CARP and then they will use the Resilient Fairfax for tracking and follow-up. Since the Community Advisory Group is advising the Office of Environment and Energy Coordination rather than a political body it is not open to FOIA.

The OEEC has been holding meetings with the Fairfax County business community (including Leidos). They have focused on 9 strategies:
 - a. Increase energy efficiency and conservation in existing buildings
 - b. Pursue beneficial electrification in existing buildings
 - c. Implement green building standards for new buildings
 - d. Increase renewable energy in the grid
 - e. Increase production of onsite renewable energy
 - f. Increase energy supply from renewable natural gas (RNG), hydrogen, and power-to-gas (the idea is to create natural gas with renewable electricity).
 - g. Increase electric vehicle adoption
 - h. Support efficient land use, active transportation demand management to reduce vehicle miles traveled
 - i. Increase fuel economy and use of low carbon fuels for transportation. These strategies are all well and good, but there is no real plan to implement them. How are they going to ...? There was a public feedback meeting last night and another one tomorrow 7-8:30 pm.
