#### Program: Greater Washington 2050 Coalition

#### Guest Speakers:

#### Sharon Bulova; Coalition Chair, Braddock District Supervisor

Sharon Bulova, first elected in November 1987, represents the Braddock District on the Fairfax County Board of Supervisors. Mrs. Bulova serves as the Board's Vice Chairman and chairs the Board's Budget Committee.

Mrs. Bulova has been a member, and past chairman, of the Northern Virginia Transportation Commission since 1988. She is a founding member of the (VRE) Virginia Railway Express Operations Board since its inception in 1989. Under her leadership, commuter train service for Northern Virginia has advanced from a speculative proposal to a successful reality.

In the summer of 2004, Mrs. Bulova was appointed by Gov. Mark Warner to chair the Governor's Commission on Rail Enhancement for the 21st Century in the Commonwealth of Virginia, which recommended the creation of a State Rail Advisory Board. In the fall of 2005, she was elected the first chairman of that board, which makes recommendations to the Commonwealth Transportation Board to fund projects (both freight and passenger) that have a significant public benefit.

As a member and past chairman of the Northern Virginia Regional Commission, Mrs. Bulova champions regionalism to address our metropolitan area concerns. She is a member of the Council of Government (COG) Metropolitan Washington Air Quality Committee and is past chairman of COG's Metropolitan Development Process Committee.

Mrs. Bulova regularly engages her Braddock constituents in Community Dialogs and Task Forces. Some of these efforts have addressed: Transportation and Land Use; Preventing Gang Activity, Braddock Tomorrow (a community visioning series in 2006) and Revitalization of "mature" neighborhoods. Mrs. Bulova is a founder of the Braddock Nights Summer Concert Series and in 1995 founded Faith Communities in Action, a countywide network of faith communities that fosters a working relationship between faith communities and County government to better meet the human services needs of our constituents and congregations. A newly created Office of Interfaith/Community Outreach provides organizational structure for this effort.

Throughout 2008, Mrs. Bulova has served as chairman of Greater Washington 2050, a new regional initiative to improve the quality of life for Washington area residents in the next 50 years by fostering stronger regional cooperation and planning. The Greater Washington 2050 Initiative is led by COG and a coalition of public, business, civic and environmental stakeholders.

#### • Community Budget Dialogues on the 2010 Fairfax County Budget (Kosmo Tatalias)

President Jeff Parnes urged that Federation members attend the County's sessions for input regarding the FY 2010 Budget. Little information was available about these sessions beforehand.

I attended the Sept 20 "Community Budget Dialogue" at the Chantilly Regional Library and hereby report on what transpired so that others who may attend future dialogues will know what to expect. It is very important that the Federation provide input at these sessions because of the 12% shortfall in the anticipated 2010 revenues. That's one-eighth of the pie!!

The Chantilly dialogue must have been the "A List" of the four such sessions scheduled to be held around the County that day, because it was attended by Supervisor Sharon Bulova, who is Chair of the BOS Budget Committee, and by Susan Datta, Director of the Department of Management and Budget. Supervisor Bulova was there as an observer and sampled all the discussion groups.

Ms. Datta gave a very brief overview of county services and the county budget, and Dean Tistadt, Chief Operating Officer of the FCPS Facilities & Transportation Services, did likewise for the FCPS. There was some Q&A after each presentation. After a 5 minute break, we formed four discussion groups (of about 8 or 9 citizens each, plus a Budget Office employee or two) and were asked to take 55 minutes to answer three questions, which are described below. One citizen per group served as discussion facilitator and outlined the conclusions reached on a flip chart. After the confabs, the facilitator presented the group's conclusions to the plenary audience.

A paraphrasing of the three questions (and suggested time allotment) for the discussion groups follows.

- 1. (30 minutes) Which services provided by Fairfax County do you think are:
  - a. critical you oppose reductions that would change quality and level of service
  - b. important you would support certain reductions
  - c. non-essential you could do without.

2. (15 minutes) Based on your answers to question 1, what specific suggestions do you have for the development of the 2010 budget?

3. (10 minutes) What do you want County decision makers to consider before making their final decisions on the 2010 budget?

I did not take detailed notes, but the answers my group (and others) gave did not completely stick to the format requested. There was strong support in each group for Education, Public Safety, and Human Services. Some specifics were suggested for reductions and for greater efficiencies. I don't think anything was suggested as non-essential. Everyone was against the Dillon Rule, and every group suggested that the BOS consider the possibility of raising taxes at least some to avoid savaging services completely.

Briefing materials had not yet been put online (and would have been useful to prepare for the meeting), but now they can be found at <u>http://www.fairfaxcounty.gov/dmb/fy2010/dialogues/</u>. Only a handful of the slides in the County Budget Presentation posted on that web site were actually shown at the meeting. Some of the slides in the Reference Materials were available from the Budget Office employee meeting with the discussion group.

BTW, although you can provide budget comments online, you are limited to 1500 characters. For comparison, this message has about 4000. It happens that I sat next to Pat Wirth, who is President of the Parent Teacher Student Association (PTSA) and who is following the FCPS Budget process. She had other PTSA members to attend the other 3 community dialogues being held that day, in order "to make sure that all were conducted in the same way" - and, I'm sure, to be strong advocates for the FCPS. When I mentioned the Federation, she said she had only recently heard about it, so I suggested that she might find it useful to get in touch with Dr. Dane, and she said someone had already mentioned his name. I have sent her e-mail in the hopes of speeding up their introduction.
