> The Federation's Budget Committee attended the Community Dialogues and initially drew up a proposed budget resolution which was agreed to by the Federation's Board of Directors. The Federation membership debated and modified the proposed resolution and adopted this package on March 25, 2010.

As you know, our members represent decades of volunteer involvement in the county and bring considerable experience and compassion to our discussions. We, like you, know the budget is not just numbers but represents services to constituents, many of whom are our most vulnerable and dependent citizens.

We acknowledge the very difficult challenges before you this year and understand that no county agency will be spared from substantial reductions in services. I want to specifically extend my thanks to Charlie Hall, Kosmo Tatalias, Charlie Dane, Flint Webb, Fred Costello, Carol Hawn, Tania Hossain and other Federation members for their efforts in producing this document.

Beyond our specific recommendations on individual budget items, let me provide some thoughts on the process. As indicated in this document we believe there is a need for an independent county agency similar to the Federal Government Accountability Office which would review county performance. We also believe that there should be a citizens' advisory board which would be constituted for the full year, not just at budget time. The scope of these organizations should cover both the county and its school system. We appreciate the county's transparency, but more is needed, specifically the ability to get in-depth information so as to enable the detailed review of county performance.

I ask that you take the time to review our full Resolution Package, including our stance on the Capital Improvement Program. I hope our recommendations will receive favorable consideration during your budget deliberations in the following weeks.
